Council 14504 Meeting Minutes February 8, 2022

Call to Order:

The meeting was held in person. The Grand Knight, Steve Berns, called the Council to order at 7:30 pm and led the Opening Prayer and Pledge of Allegiance.

Approval of Meeting Minutes

Mike Nowak previously e-mailed the Council meeting minutes from January 11, 2022, to all members via Council newsletter. After motions by Danny Sprouse and Jeffrey Travers, the Council approved the minutes as published.

Chaplain's Message:

Nothing reported.

Grand Knight's Report:

Recruitment – A Recruitment Delta Church Drive at the Parish is anticipated late February or March. Standby for details.

Super Cash Bonanza – Super Cash Bonanza is the Ohio State Council's annual charity campaign which provides significant amount of funding to our church, school systems and community projects. The campaign is funded through ticket sales. The Grand Knight will pick up tickets for the Council on Saturday, February 12th.

Fraternal Benefits – There will be a fraternal benefits webinar presentation on March 10th at 7:30 PM. Registration for the webinar is required; the Grand Knight will send details by e-mail.

Membership Incentives – The February Membership Incentives allow the Proposer to receive \$30.00 for each Council that obtains their membership quota by February 14th. The council that maintains that quota through June 30th will receive \$100.00

Donut Sunday – Scheduled between Parish Masses on Sunday, February 20th.

First Holy Communion – The Parish has asked the Council to assist with the receptions following the First Communions after the 5:00 PM Mass on April 30th, the Sunday Masses on May 1st, and the Sunday Masses on May 8th. The Council will provide donuts; the cost will be reimbursed by the Parish

Financial Report:

Treasurer, Cal Frank, reported the current deposits, expenses, and checking account balance. He also read letters of appreciation from the Charities of Kentucky (for \$250 donation towards tornado relief) and from the Oasis House (for \$250 donation supporting women survivors of exploitation and trauma).

The Financial Secretary, Bob Luppino, reported that 80 of 180 members have paid their annual membership dues. He encouraged all members to pay as soon as possible.

Deputy Grand Knight, Don Hirst, discussed plans for the Council to lead the Stations of the Cross during Lent. He also discussed plans to distribute eggs to children during Easter.

Report of the Fourth Degree

Nothing reported.

Field Agent Report

Field Agent, Jim Warner, reported that his goal is to reach out to as many members as possible. He also discussed the value of permanent (Whole Life) insurance which has three major benefits: 1) use for generational wealth transfer, 2) use with Long Term Care Insurance, and 3) use as an asset to draw supplemental income.

District Deputy Report

District Deputy, Ken Haacke, was not able to attend. John Hoffman reported on the upcoming semi-annual audit.

Unfinished Business:

Mulch Sale – Cal Frank discussed the upcoming mulch sale; deliveries are scheduled April 23rd.

New Business:

Fenwick Society – The Bishop Fenwick Society honors the legacy of Cincinnati's first bishop, Edward Fenwick (1822–1833) which supports the education of tomorrow's priests, deacons, and lay ministers. No payment was made last year although \$500 was budgeted. Michael Friel made a motion to donate \$500. The motion was seconded and approved by the Council.

Ultrasound Machine – Mike Tortoricci made a motion to donate \$500, as budgeted this year, to Elizabeth's New Life Center for purchase of an ultrasound machine. Danny Sprouse seconded the motion and the Council approved.

Parish Fish Fry – Mike Manzo announced a Parish Fish Fry is planned for March 25th; he asked Knights to volunteer; sign up will be after Masses in early March.

Ushers – Michael Friel discussed the need for ushers during the 08:30 and 11:00 AM Masses. He also discussed the need for usher security training.


