## Council 14504 Minutes for August 9th, 2022

#### **Call to Order:**

The meeting was held in person. The Grand Knight, John Hoffman, called the Council to order at 7:30 pm and led the Opening Prayer and Pledge of Allegiance.

#### **Approval of Meeting Minutes**

Mike Nowak previously e-mailed the Council meeting minutes from July 12<sup>th</sup>, 2022, to all members via Council newsletter. After motions by Cal Frank and Shawn McManamy, the Council approved the minutes as published.

#### **Chaplain's Message:**

Nothing reported.

#### **Grand Knight's Report:**

140<sup>th</sup> Supreme Convention – The Grand Knight discussed the recent Supreme Convention held in Nashville, Tennessee, August 2<sup>nd</sup>-4<sup>th</sup>. This year's theme was "Stand in the Breach". Supreme Knight, Patrick Kelly, reminded the nearly 2,400 Knights in attendance that "a Knight is a leader who stands in the breach. We defend the faith. We protect the family. And when a need arises, we rise to meet it — with charity, unity and fraternity". The Supreme Knight also announced the launch of the new ASAP (Aid and Support After Pregnancy) program, which aims to distribute at least \$5 million to pregnancy resource centers, maternity homes and other organizations across the country that give direct assistance to new mothers and babies.

Annual Budget – The Grand Knight reviewed the proposed annual budget for the 2022-2023 fiscal year.

Football Frenzy – Tickets are now available.

Awards – The Grand Knight announced the Council earned Star Council during the 2021-2022 fraternal year including 2<sup>nd</sup> Place in the State of Ohio for Division II Councils, and 5<sup>th</sup> Place overall, earning the Ohio "Council of Distinction" award.

Letters of Appreciation – The Council received letters of appreciation from the "Charities of Kentucky" for a recent \$500 donation and from Wyatt Key (Cal Frank's grandson) for a \$400 donation toward construction of picnic tables as part of his Eagle Scout project. The Council also received a letter from Mrs. Sue Fullenkamp (Al Fullenkamp's wife) expressing gratitude for being selected as the Council's "Lady of the Year".

Congratulations – Congratulations to District Deputy, Ken Haacke, for earning the Paul Gruhler award. The Paul Gruhler Award is sponsored by the Dayton Chapter of the Knights of Columbus and dates back to 1975. It is named in honor of Paul Gruhler who was dedicated to his family, his community and epitomized the principles of the Knights of Columbus: Charity, Unity Fraternity and Patriotism.

#### **Financial Report:**

Treasurer, Mike Nowak, reported the current deposits, expenses, and checking account balance.

The Financial Secretary, Bob Luppino, reported on the bills. He also reported that the Council's semi-annual financial audit was completed, and the associated paperwork will be sent by August 15<sup>th</sup>.

Membership – State Membership Director, Michael Freil, reported on the state recruitment goals for the state. He also spoke about his very positive experience attending the Supreme Convention.

Right to Life – Danny Sprouse encouraged donation to the Elizabeth New Life Center which recently incurred over \$70,000 of expenses due to vandalization.

Parish Activities – Mike Manzo requested volunteers for the following upcoming events:

Parish Golf Outing – Scheduled August 28<sup>th</sup> at the Locust Grove Golf Course.

Spaghetti Dinner – Scheduled September 24<sup>th</sup> and sponsored by the Council. Proceeds go to supporting Seminarians.

Parish Fish Fry – Scheduled November 18<sup>th</sup>.

#### **Report of the Fourth Degree**

#### **Field Agent Report**

Field Agent, Jim Warner, discussed the many financial products offered by the Knights of Columbus and encouraged all members to conduct a "Financial Needs Analysis" which is an annual benefit offered by the Knights of Columbus. He also encouraged Knights to earn the "Shining Armor" award which is awarded to those men that exemplify a true Knight of Columbus. Chapter Delegates – Danny Sprouse made a motion to accept Michael Freil, John Hoffman, and Cal Frank as the Council's primary delegates to the Dayton Chapter with alternate Delegates Steve Berns, Mike Nowak, and Sean Gammon. Sean McManamy seconded the motion which was subsequently approved by the Council.

Donation – Cal Frank made a motion that the Council donate \$500 to the "KofC Charities of Kentucky" for those in need due to the flooding in eastern Kentucky. Ken Haacke seconded the motion which was subsequently approved by the Council.

Council Shirts and Nametags – Cal Frank reported that Council shirts are available for sale, and that he will order nametags (for Council members who attend at least 5 meetings) twice a year, in June and November.
