Through his scholarly insights and important biblical connections, Mass will come alive for you as never before!

Council 14504 Minutes for September 13th, 2022

Call to Order:

The meeting was held in person. The Grand Knight, John Hoffman, called the Council to order at 7:30 pm and led the Opening Prayer and Pledge of Allegiance.

Approval of Meeting Minutes

Mike Nowak previously e-mailed the Council meeting minutes from August 8th, 2022, to all members via Council newsletter. After motions by Sean Gammon and Danny Sprouse, the Council approved the minutes as published.

Chaplain's Message:

Grand Knight's Report:

Eucharistic Revival – The National Eucharistic Revival, launched June 19 on the Solemnity of the Most Holy Body and Blood of Christ, is a three-year initiative sponsored by the US bishops that aims to inspire, educate, and unite. It has a mission to "renew the Church by enkindling a living relationship with the Lord Jesus Christ in the Holy Eucharist." The Grand Knight proposed a Council initiative committing all Knights to one hour of adoration during Advent. More to follow.

By Laws – The Grand Knight proposed new Council "By-Laws", previously coordinated with the Council's officers. Changes involved removing an "initiation fee", the routing of vouchers, and the dedication of 2 masses per year for deceased Knights.

Football CRAZR – See the Grand Knight for tickets. Each ticket is \$20 which benefits Ohio Kof C. This program covers the last 10 weeks of pro football games played in the 2022 NFL season. Winners are determined by ticket holders with the four teams that score the most – or the least – number of points in that given week of games.

Financial Report:

The Financial Secretary, Bob Luppino, reported the current deposits, expenses, and checking account balance for the Treasurer, Mike Nowak. He also reported three vouchers: 1) dated 2 September 2022, \$17.00 to Cal Frank for Council shirts, 2) dated 13 September 2022, \$20.00 to John Hoffman for donation to the Parish for Knight memorial masses, and 3) dated 13 September 2022, \$100 to Steve Berns for the Council donation to the upcoming "Walk to End Alzheimer's".

Mother Teresa: No Greater Love – Encouraged all Knights to see the upcoming film, "Mother Teresa: No Greater Love" scheduled in theaters October 3rd and 4th. This film commemorates the life of Mother Teresa of Calcutta. It features unprecedented access to both institutional archives and the apostolates of the Missionaries of Charity.
